THIS **AGREEMENT** CONTAINS THE EXCLUSIVE TERMS AND CONDITIONS UNDER WHICH BIO-PRODICT B.V., A DUTCH CORPORATION (TOGETHER WITH ITS AFFILIATES, "BIO-PRODICT") WILL PROVIDE SERVICES AND ACCESS TO TOOLS AND PRODUCTS TO YOU (TOGETHER WITH THE ENTITY FOR WHICH YOU REGISTER ON BEHALF OF "YOU" OR "CUSTOMER"), AND THEY WILL GOVERN ALL YOUR PRODUCT ORDERS, SERVICE REQUESTS, AND PURCHASES FROM BIO-PRODICT.

IF YOU CANNOT OR DO NOT AGREE TO ALL THE TERMS AND CONDITIONS IN THIS AGREEMENT, YOU ARE PROHIBITED FROM ACCESSING, USING, AND FROM PURCHASING ANY SERVICES OR PRODUCTS FROM BIO-PRODICT. ANY DEROGATION REQUIRES A SEPARATE AND MUTUALLY APPROVED ADDENDUM OR AGREEMENT.

BIO-PRODICT RESERVES THE RIGHT TO AMEND THIS AGREEMENT AT ANY TIME WITHOUT SPECIFIC NOTICE TO YOU. THE CHANGES WILL NOT BE RETROACTIVE, AND THE MOST CURRENT VERSION OF THE TERMS, WHICH WILL ALWAYS BE AT BIO-PRODICT.COM, WILL GOVERN OUR RELATIONSHIP WITH YOU DETERMINED BASED ON THE POSTED "LAST UPDATED" DATE. AT ANY NEWLY AGREED ACCESS TO SERVICES OR USE OF THE PRODUCTS OR SERVICES AFTER THOSE REVISIONS BECOME EFFECTIVE, YOU AGREE TO BE BOUND BY THE REVISED TERMS.

1. Introduction.

In these General Terms:

a. "Bio-Prodict" means Bio-Prodict B.V., the user of general terms and conditions (GT&C) (within the meaning of section 231(b) of Book 6 of the Netherlands Civil Code).

b. "Customer" means the natural person or legal entity, or his/its legal successor, on whose behalf or on whose account Bio-Prodict has entered into an agreement to supply goods or services and/or carry out work (within the meaning of section 231(c) of Book 6 of the Netherlands Civil Code).

This General Terms and Conditions (GC&T) apply to all offers, quotations, contracts and agreements between Bio-Prodict and its contract partners and customers. Bio-Prodict may from time to time issue new or updated versions of this General Terms and Conditions, identified by version date. The new version applies for all quotations, agreements or contracts sent and accepted at or after the corresponding version date (LAST UPDATED). The applicable version is indicated for reference in the Quotation and is available from the website and will be sent to customers upon request.

2. Definitions.

- 2.1. **3DM Client System**: The customized tool (Appendix 1) to represent and visualize generated and selected protein mutation data and variants resulting from application of the Customised 3DM Tool.
- 2.2. **Agreement**: an agreement is concluded and these General Terms come into effect if one of the following situations applies:
 - a written consent, or consent by e-mail, to the Quotation has been received in good time
 - the invoice with specification sent by Bio-Prodict has been paid
 - if Customer requests Bio-Prodict to start work before it has issued a Quotation or before Bio-Prodict has received your consent to the Quotation
- 2.3. **Applicable Law**: all applicable rules, regulations and laws.
- 2.4. Bio-Prodict suite of Protein Analysis and Predictive Tools
 - 2.4.1.1. **3DM Discovery**: system to screen proteins for target discovery and drug design.
 - 2.4.1.2. **3DM Engineering:** identify starter proteins and refine functional properties
 - 2.4.1.3. **3DM Antibodies:** antibody development using sequence property insights
 - 2.4.1.4. **Helix Pathogenicity:** predict missense variant pathogenicity

Each of the Protein Analysis and Predictive Tools makes use of proprietary AI Networks developed and applied by Bio-Prodict. The AI Networks may be used in one or more iterative rounds to refine the results.

- 2.5. **Business user**: employee of Customer who is authorized by the Customer to use the 3DM Client System.
- 2.6. Customized 3DM Tool: The tool based on one or more (a combination of) tools from the Bio-Prodict suite of Protein Analysis and Predictive Tools 2.2.1.1 to 2.2.1.3 above, or any other software tool developed or offered by Bio-Prodict for the specified Protein Family and other Customer Input and used to build the 3DM Client System and specified in the Quotation.
- 2.7. **Customized Tools**: Any 3DM Client System built with (a combination of) Customized 3DM Tools and/or Helix Pathogenicity
- 2.8. **Customer**: company accepting the Quotation of Bio-Prodict to build and deliver a Customized Tool and other Bio-Prodict proprietary products and render related Services
- 2.9. **Customer Results**: Any results arising from the use of the Customized Tool, and the and other Bio-Prodict proprietary products

- 2.10. **Customer Input**: the proprietary and confidential information of Customer disclosed to Bio-Prodict, including without limitation, Protein Family data and used to build any Customized Tools.
- 2.11. **General Terms and Conditions (GT&C)**: this general terms and conditions including all appendices.
- 2.12. **Helix Pathogenicity**: Data set of AI predicted pathogenicity for Human SNPs, optionally combined with (parts off) the 3DM Client System, as specified in the Quotation and built upon the Bio-Prodict Tool 2.2.1.4 as specified for the specified Protein Family and other Customer Input.

2.13. Licenses.

- 2.13.1. **Commercial License**: the right to use the 3DM Client System, Customized Tool, Helix Pathogenicity and other Bio-Prodict proprietary products as described in the Quotation, and in Art 6 and using the Customer Results for internal and commercial exploitation.
- 2.13.2. **Research License:** the right to use the 3DM Client System, Customized Tool and other Bio-Prodict proprietary products as described in the Quotation for research purposes only. Conditions for use and publication of results are subject to restrictions as detailed in Appendix 4.
- 2.14. **Protein Family**: The protein family data as disclosed by Customer and identified in the Quotation.
- 2.15. **Quotation**: The quotation as presented by Bio-Prodict to Customer with details as to the Customized Tool including the Customer Input, Timeframe, Price and Services
- 2.16. **Services**: among others, and not limitative, building or modifying software, performing analysis of (literature-) data, building client specific applications (Customized Tools)
- 2.17. **Supplier Server**: Server on which the Customized Tools and other Bio-Prodict proprietary product is installed located at ITB2 (https://itb-kwadraat.nl/) premises and linked to the internet.
- 2.18. **Third Party**: a party other than Customer, Bio-Prodict or their respective affiliates, officers, directors, employees, agents and representatives.
- 2.19. **Update**: Renewal of the following data in the Customized Tool:
 - Collection and integration of newly released sequences of the Protein Family.
 - Collection and integration of newly released data related to the Protein Family collected by the 3DM tool (Appendix 1.2).
 - Collection and integration of newly released protein structures.
- 2.20. **Upgrade**: any new release, version, enhancement, correction, patch, bug-fix or other modifications (regardless of how characterized) of the software components of the Bio-Prodict suite of Protein Analysis and Predictive Tools that are distributed, designed, developed or created by or for Bio-Prodict.

3. Work:

Building the 3DM Client System and Customized Tool for the Customer Input and providing access to the Supplier Server or any other Services as offered in a Quotation and agreed.

4. General Provisions.

4.1. These General Terms are applicable to all offers of Bio-Prodict, Quotations and Agreements or contracts between the Bio-Prodict and Customer under which Bio-Prodict supplies products or services and/or carries out work, even if these products,

- services and/or work are not specified in the Agreement. Departures from these General Terms and Conditions shall apply only if they are expressly agreed by the parties in writing.
- 4.2. All offers are without obligation, unless the offer expressly indicates otherwise.
- 4.3. Applicability of any purchase or other conditions of the Customer is expressly rejected.
- 4.4. If and as soon as it is established that one or more of the provisions of these General Terms is/are void or has/have been set aside, the remaining provisions of these General Terms and Conditions shall remain in full force and effect and Bio-Prodict and the Customer shall consult one another in order to agree new provisions to replace the ones that are void or have been set aside; as far as possible the object and effect of the provisions that are void or have been set aside shall be reflected in the amendments.
- 4.5. The failure by Bio-Prodict at any time to require performance of one or more of the provisions of an Agreement shall in no way whatsoever affect the rights of Bio-Prodict to demand performance by the Customer at a later time.
- 4.6. The Customer shall not, otherwise than for factoring purposes, assign or in any other way transfer rights and/or obligations under the Agreement or contracts concluded between itself and Bio-Prodict, unless with the prior written consent of Bio-Prodict.

5. Modification of the General Terms and Conditions.

5.1. Bio-Prodict reserves the right to modify or add to these General Terms and Conditions. A new version will only apply to Quotations and Agreements entered into after the modified General Terms come into effect (Section 1).

6. Licensed not sold.

- a. **Commercial License**. The access to the 3DM Client System and Customized Tool is licensed, not sold. The licensee is entitled to all benefits of the use of the 3DM Client System and ownership and exploitation of any Customer Results derived from its use as described below.
- b. **Research License**. Universities and Research Institutions (not for profit) may request a Research License at a reduced fee. The Research License will entitle institutions to use the license for research purposes only and not for any commercial activity whatsoever. The limited support and restricted use of results are detailed in Appendix 4.

(1) Customized 3DM Tool.

The Customized 3DM Tool consists of a data set as defined in article 1(1)(a) of the Dutch Database Act (Databankenwet) and is therefore protected against unauthorized use.

- 6.1. The Customized 3DM Tool is built using the data set, AI Networks and Customer Input and is accessible using the 3DM Client System
- 6.2. The Customized 3DM Tool is owned by Bio-Prodict, and is licensed, not sold.
- 6.3. Subject to Customer's compliance with the terms and conditions of this General Terms and Conditions, Bio-Prodict hereby grants Customer a non-exclusive, non-transferable license to use the 3DM Client System and Customized 3DM Tool. Only Business Users are authorized to use the 3DM Client System and Customized 3DM Tool. Customer ensures that anyone who uses the Customized 3DM Tool does so only on Customer's behalf and complies with the terms of this General Terms.
- 6.4. Customer is responsible for all usage of the 3DM Client System and Customized 3DM Tool including without limitation, any acts and omissions of any Business User. Customer shall ensure that all Business Users comply with this GT&C, and any other applicable additional terms including, but not limited to, the Agreement.

6.5. Customer is the owner of and may commercially exploit the Customer Results.

(2) Helix Pathogenicity

- 6.6. The Helix Pathogenicity as described in Appendix 2.
- 6.7. The Helix Pathogenicity and data is owned by Bio-Prodict and licensed to the Customer, not sold.
- 6.8. The license to use the Helix Pathogenicity is to Business Users as designated by Customer only and limited to the period as defined in the Agreement or Quotation, and subject to payment of the license fee.
- 6.9. The Helix Pathogenicity and data is strictly confidential and Customer will take utmost care to protect it from becoming public or accessible for third parties.
- 6.10. Unless otherwise agreed upon in the quotation or agreement with Customer, Customer is the owner of and may commercially exploit the Customer Results and Customer Products as defined in Appendix 2.
- 6.11. The license to Customer does not cover the use of the Helix Pathogenicity, the database or parts thereof to offer services for or at the request of third parties. For such use a separate license is required.

7. Price and payment.

- 7.1. The costs of the 3DM Client System to access the Customized Tool or any other offered Services are specified in the Quotation.
- 7.2. All prices are in Euro (€) and exclusive of value added tax (VAT) and other levies imposed by governmental or other authorities.
- 7.3. UNLESS OTHERWISE STATED IN QUOTATION OR AGREEMENT, CUSTOMER SHALL PAY ALL INVOICES WITHIN 45 (FORTY-FIVE) DAYS AFTER THE DATE OF RECEIPT OF THE INVOICE (Payment Term) WITHOUT ANY RIGHT TO SUSPENSION, REDUCTION OR SET-OFF.

7.4. Credit restriction.

- 7.4.1.If payment of an amount due has not been received within the Payment Term (par 6.3) 5% credit restriction to the outstanding amount will be invoiced with immediate effect.
- 7.4.2.If the payment of the total amount due has not been received within one month after the expiration of the Payment Term a further credit restriction of 5% of the outstanding amount is invoiced for each month thereafter with immediate effect.
- 7.4.3.Bio-Prodict reserves all rights to take judicial or extrajudicial steps to recover the payments.
- 7.4.4.The charged amount in 6.4.1 and 6.4.2 is exclusive of any collection-, recovery- or extrajudicial costs.

8. Delivery and timeframe.

(1) Customized 3DM Tool

- 8.1. Customer gains access to the Supplier Server by using an internet connection. In order to use the 3DM Client System and Customized Tool, Customer receives a password/access code. Bio-Prodict is by no means liable for loss or unauthorized use of the password/access code
- 8.2. An internet connection is Customer's responsibility.

- 8.3. Bio-Prodict shall undertake all reasonable measures to assure that no party other than mentioned in this Agreement can obtain access to the Customized Tool built for the Customer.
- 8.4. Concerning the accessibility of the Customized Tool, the Standard Level Agreement (SLA, Appendix 3) applies.
- 8.5. Access to the 3DM Client System and Customized Tool is provided for a period as defined in the Quotation, Agreement or invoice.

(2) Helix Pathogenicity

- 8.6. Upon acceptance of the Quotation and payment of the fee by Customer a valid license is in place and Bio-Prodict will give access to the Helix Pathogenicity or related Bio-Prodict software tools or AI predictions.
- 8.7. Access to the Helix Pathogenicity or related Bio-Prodict software tools is provided for a period as defined in the Quotation, Agreement or invoice.

(3) General

- 8.8. Bio-Prodict may retain any items, products, proprietary rights, data, documents, software, data files and (interim) results of the service provided by Bio-Prodict received or created within the context of the Work and/or, upon advance written notice to Customer, suspend access to the Customized Tool, contrary to an existing obligation to deliver or transfer these, until such time as Customer has paid all undisputed amounts due to Bio-Prodict.
- 8.9. All delivery dates quoted by Bio-Prodict are determined to the best of its ability on the basis of the information available at the time the Agreement was concluded and will as far as possible be observed. However, Bio-Prodict will not be in default by the mere fact of its exceeding a delivery date it has quoted. Bio-Prodict is not bound by any delivery date which can no longer be met on account of circumstances beyond its control. If any time limit threatens to be exceeded, Bio-Prodict and the Customer shall consult one another as soon as possible.
- 8.10. The risk of loss or damage to goods which are the subject of the Agreement pass to the Customer the moment they are put at the actual disposal of the Customer or a third party contracted by it.

9. Confidentiality & Intellectual or industrial property rights.

- 9.1. The Agreement shall not affect, or grant any rights to, patents, know-how or other intellectual property owned by the parties prior to the commencement of the Work or modifications, innovations or developments thereto arising during the Work.
- 9.2. Bio-Prodict Background. All intellectual and industrial property rights to software, websites, databases, equipment or other materials developed or provided under this Agreement, such as analyses, designs, documentation, reports, offers, as well as preparatory materials in that regard, not being Customer Results, shall be held solely by Bio-Prodict, its licensors or its suppliers. Customer shall only acquire the rights of use explicitly granted in this General Terms and by law. Any other or more extensive right of the Customer to reproduce software, websites, databases or other materials shall be excluded. A right of use to which the Customer is entitled shall be non-exclusive and non-transferable to third parties. Bio-Prodict will not use the Customized Tools or analytical tools to identify valuable sequences, mutations, proteins or any other results for its own commercial exploitation.
- 9.3. Customer Background. All data and information provided by Costumer are the exclusive property of Customer and shall be considered Costumer's confidential information

- 9.4. Bio-Prodict Foreground. Foreground created by or on behalf of Bio-Prodict specifically in the field of improvements and additions to 3DM Client System and Customized Tools and analytical tools and tools for access, generating and structuring data or any alternative technology to facilitate the exploration of sequence-structure-function relations or mutation effect data accrues to Bio-Prodict, unless provided otherwise in the GT&C or explicitly agreed with Customer in writing in any other way. Customer Results and Customer Products are excluded.
- 9.5. Customer Foreground. For any Foreground (Customer Results and Customer Products) created within the context of this Agreement by using the 3DM Client System and Customized 3DM Tools provided by Bio-Prodict or using the Helix Pathogenicity (as defined in Appendix 2), the relevant IP Rights or the exclusive right to vest these will accrue to Customer unless otherwise agreed in the quotation or other agreement between Bio-Prodict and Customer. This will include IP rights to proteins, sequences or mutations that the customer might find and develop with the Customized Tools based on the Bio-Prodict 3DM datasets or based on the Helix Pathogenicity dataset.
- 9.6. Customer and any Business User(s) are not allowed to copy, reverse engineer, decompile or disassemble the Customized Tools, or to copy or use the underlying database or parts thereof other than explicitly granted in this General Terms or the Quotation.
- 9.7. Customer shall not be allowed to remove or modify any designation concerning the confidential nature or concerning copyrights, trademarks, business names or other intellectual or industrial property rights from the software, websites, databases, equipment or materials.
- 9.8. Bio-Prodict shall be entitled to take technical measures to protect integrity of the 3DM Client System and Customized Tools and to enforce agreed restrictions in the duration of the right to use the Customized Tools. Customer shall not be allowed to remove or circumvent such technical measures.

10. Upgrades.

- 10.1. During one year after this Agreement has become effective, available Upgrades shall be installed by Bio-Prodict.
- 10.2. If no additional or different terms are agreed upon, this Agreement will apply to all Updates and Upgrades.
- 10.3. Bio-Prodict is by no means liable for any consequences if supporting software provided or licensed by Third Parties is no longer available or no longer updated. Bio-Prodict will do good faith efforts in advising Customers as to replacement software

11. Termination.

- 11.1. One party shall be entitled to terminate the Agreement if the other party, after a proper and detailed written notification of default, in which a reasonable period is set to remedy the defect, imputably fails to perform one or more essential obligations pursuant to the Agreement.
- 11.2. If by virtue of its nature and substance the Agreement is not terminated by the conferring of a specific benefit it may be terminated by either party after proper consultation, and stating the reasons, by means of written notice. If the parties have not agreed a period of notice, a reasonable period must be observed when notice is given. Bio-Prodict will in that case never be obliged to pay any compensation for giving notice.
- 11.3. If the Customer fails to fulfil any obligation arising out of the Agreement, or fails to fulfil it properly or in good time, or in the event of the protective bankruptcy, bankruptcy petition, administration order or liquidation of goods of the Customer, Bio-Prodict shall

- be entitled to terminate the Agreement immediately, in whole or in part, without notice of default or court order being required.
- 11.4. If the Agreement is terminated, the Customer agrees to promptly discontinue use of and destroy all of Customer's copies of the 3DM Client System and Customized Tool or parts thereof. Any terms of this Agreement that by their nature extend beyond termination of this Agreement remain in effect until fulfilled.
- 11.5. If at the time the Agreement is terminated the Customer has already or should already have received benefits by way of implementation of the Agreement, the termination shall not affect these benefits and the corresponding payment obligations, unless Bio-Prodict is in default in respect of these benefits. Any amounts Bio-Prodict has invoiced or would have been able to invoice in connection with whatever has already been supplied or carried out before termination will remain due in full subject to the provisions of the previous sentence and will become immediately payable at the moment of termination.
- 11.6. In the event that the Agreement ends in any way, the GT&C and provisions in the Agreement that are intended to continue to apply in full after the end of the Agreement such as, but not limited to, provisions in respect of liability, rights of use, confidentiality, payment, choice of forum will continue to apply in full.

12.Liability.

- 12.1. Neither Party is liable for indirect loss or damage, including consequential damage, loss of profits, loss of savings and loss or damage resulting from interruption of business.
- 12.2. Apart from the cases mentioned in this clause, Bio-Prodict accepts no liability whatsoever for loss or damage, irrespective of the ground on which any action for damages might be based.
- 12.3. If and to the extent this is covered by its insurance, Bio-Prodict shall only accept liability for direct loss or damage suffered by the Customer which results from an imputable failure in the performance of its obligations under the Agreement or a wrongful act, up to the amount of the payment to be made by this insurance, which will at any time meet industry standards.
- 12.4. If the insurer should for any reason fail to pay out, or if the liability for the loss or damage is not or not sufficiently covered by any insurance, Bio-Prodict shall only accept liability for the direct loss or damage suffered by the Customer which results from an imputable failure in the performance of its obligations under the Agreement or a wrongful act, up to the amount of the price Bio-Prodict is to charge the Customer or the amount of the payment to be made by the insurance, if higher.
- 12.5. The Customer shall indemnify and hold Bio-Prodict harmless against any claims from third parties in respect of the use by those third parties of goods, services and/or work supplied to them or otherwise placed on the market by the Customer, which came into being wholly or partly on the basis of the goods, services and/or work supplied to the Customer or otherwise placed on the market by Bio/Prodict.
- 12.6. Liability on the part of Bio-Prodict on account of an imputable failure in the performance of an Agreement shall arise only if the Customer has immediately and duly notified Bio-Prodict of its default in writing, thereby setting a reasonable time limit within which to remedy the default, and Bio-Prodict remains imputably in default even after that time limit. The notice of default must contain such a detailed description of the default that Bio-Prodict is able to respond adequately.
- 12.7. Bio-Prodict shall not be liable if a default is caused by force majeure.

12.8. The restrictions stated in this clause shall not apply if the loss or damage is the consequence of the deliberate act or gross negligence of Bio-Prodict or its managerial staff.

13. Choice of law, jurisdiction.

- 13.1. The Agreement shall be governed by the laws of the Netherlands. The Vienna Convention of 1980 (CISG) shall not apply.
- 13.2. Any dispute rising from the Agreement will exclusively be brought before the district court in Arnhem, the Netherlands, unless Bio-Prodict decides to engage in legal action before the competent court of the domicile of the Customer.

14. Miscellaneous.

- 14.1. The Agreement and the appendixes hereto contain all of the terms and conditions agreed upon by the parties hereto with reference to the subject matter hereof.
- 14.2. Appendices form an integral part of the Agreement. Any amendment to the Appendices by Bio-Prodict results in a new Version of these General Terms and is subject to Section 1 Introduction and art 14.3.
- 14.3. This General Terms can be obtained as pdf download from the website of Bio-Prodict and will be mailed to the (potential) Customer upon request. The last version issued, identified by the version date, preceding the date of the Quotation or Invoice is applicable.

Appendix 1: Specification of the customized 3DM Client System

- 1. The customized "3DM Client System" contains the following elements:
 - A data set with data concerning the Protein Family, "3DM data set" (2). The 3DM data set will contain protein data that, using the AI Network and 3DM tool and standard 3DM cutoffs, share a structural conserved core that consists of structural conserved positions compared to the target protein sequence (accession codes or the amino acid sequence of target protein(s) to be included in Quotation and/or Agreement).
 - An interactive system (AI Network) for the prediction of mutations and analyzing data of the 3DM data set "front end scripts" (3); this system may be operated in several refinement rounds.
 - Visualization tools, "3DM Viewer" (4).
- 2. Not included. The 3DM tool and AI Network (1) and 3DM data set (2) and all its scripts, such as (not limitative) scripts that 1) collect data concerning the Protein Family, 2) superimpose the protein structures, 3) build the Protein Family alignment, 4) collect amino acid related data (such as mutational data from the literature), 5) generate the 3DM Client System, is confidential and proprietary property of Bio-Prodict.




Figure 1: Schematic representation of 3DM.

- 3DM contains two parts: The first is the "3DM tool and AI Networks" (1). The 3DM tool contains scripts that builds 3DM databases and Tools (2 t/m 4) and/or AI networks such as mentioned in paragraph 2 of this appendix, and contains the following three elements (2 t/m 4):
- (2) The 3DM Tool and AI Networks: Contains proprietary AI Network to work on Protein Family specific data.
- (3) The front end scripts: these scripts take care of the communication between the data set and the visualization of the data (4).
- (4) 3DM viewer: These mostly HTML pages visualize the data inside the data set.
- (5) Represents user of the 3DM Client System.
- 3. The Customized 3DM Client System and 3DM Tool is installed on the Supplier Server (or a customer dedicated server) located at the Server Centre of ITB2 (https://itb-kwadraat.nl/). Customer gets access to the 3DM Client System via an internet connection and personal (Business User) password/access code using the 3DM viewer or via API access.

Appendix 2: Helix Pathogenicity

Definitions:

- (1) Helix.ai Dataset: The proprietary databases, based on the human genome. The dataset as developed by Bio-Prodict contains predicted effects of genetic variants, as well as, but not limited to, data describing mutations, positions and proteins, including variants and derivatives thereof.
- **(2) Helix Pathogenicity:** The Helix Pathogenicity is based upon the Helix.ai Dataset, AI Networks and Customer Input confidential information and provides access to the pathogenicity data (missense variant pathogenicity).
- (3) Access: Access to the Helix Pathogenicity is defined in the Quotation and may vary, depending on application and Customer. Examples are including, but not limited to, flat files, web applications and Application Programming Interfaces (APIs).

Proprietary Information:

Irrespective the way access to the Helix.ai Dataset is obtained, all data, selections or combinations thereof are proprietary and Confidential Information of Bio-Prodict.

Access:

Access to Helix.ai Dataset is provided via the Helix Pathogenicity and as agreed in the Quotation and Agreement. Customers obtain a license for internal use and processing of the data to develop tools and applications in their internal business environment.

Product development and data processing using Helix.ai Dataset:

Results and Products (Customer Results) derived from the Helix.ai Dataset by Customer must be distinct in purpose from the Helix.ai Dataset itself. Unless otherwise agreed in the Quotation and Agreement products and tools (Customer Results) developed using the dataset, or derived by using the dataset, that are distinct and no longer contain (a selection of, or references to) such data, or links are property of Customer and may be used and exploited commercially by Customer.

No services to or for third parties

Except for internal generation of results and product development (above) Customer is not allowed to use the Helix Pathogenicity and Helix.ai Dataset in whole, in parts or selections thereof, for use by or on behalf of third parties.

The license to Customer does not cover the use of the Helix Pathogenicity and Helix.ai Dataset to offer services to third parties. The use of the Helix Pathogenicity and Helix.ai Dataset for services like, but not limited to, diagnostic or predictive services is explicitly excluded.

For such applications a separate license is required, which can be discussed with Bio-Prodict.

Appendix 3: Service Level Agreement (SLA)

3DM Client System and Customized Tool SLA. During the term of the applicable Agreement, Bio-Prodict will give his best effort to enable that the 3DM Client System and Customized Tool will be operational and available to Customer at least 95% of the time in any calendar month. The measuring principle and parameters for the availability of the server system is defined below.

<u>Definitions</u>. The following definitions shall apply.

- "<u>Downtime</u>" means, for a domain, if there is more than a five percent user error rate. Downtime is measured based on server side error rate.
- "<u>Downtime Period</u>" means, for a domain, a period of five consecutive minutes of Downtime. Intermittent Downtime for a period of less than five minutes will not be counted towards any Downtime Periods.
- "Monthly Uptime Percentage" means total number of minutes in a calendar month minus the number of minutes of Downtime suffered from all Downtime Periods in a calendar month, divided by the total number of minutes in a calendar month.
- "Scheduled Downtime" There will be no more than 24 hours of Scheduled Downtime per calendar year. Scheduled Downtime is not considered Downtime for purposes of this SLA, and will not be counted towards any Downtime Periods.
- In case of failure to comply with the abovementioned availability, article 11 of the General Terms and Conditions applies.

Appendix 4: Research License

Research Institutions like Research departments of Universities and not-for-profit public research institutions may be eligible for a Research License at reduced costs. The Research License is subject to following restrictions:

- 1. The Research License is for research purposes only and valid only during the Term (Quotation). It does exclude all direct and indirect commercial exploitation, sales and licensing of rights to use the Research License.
- 2. The Research License is non-transferable and can never be used in projects or services for and with external partners (other Research Institutions, commercial partners or external companies) or in consortia unless BIO-PRODICT expressly states otherwise in a Product and/or Service Addendum. For the sake of clarity this also holds for other research departments and affiliates of the same institution.
- 3. Bio-Prodict will provide access to the licensed product (3DM Client System) for specific designated individuals (employees, students) of the Research Institution. These individuals qualify as Business Users, with all obligations.
- 4. Research results may be used freely in teaching and education programmes.
- 5. Publication of the research results will be allowed if the use of the licensed Bio-Prodict tools is acknowledged in a co-authorship. Bio-Prodict has the right to review the publication prior to submission to prevent the disclosure of Confidential Information and protect its intellectual property rights. Bio-Prodict has the right to put forward improvements or clarifications.
- 6. The Research Institution is obliged to notify Bio-Prodict in advance if the results from the use of the Research License are considered innovative and submission of a patent application or other measure to protect intellectual property rights is considered by the Research Institution. An agreement on ownership, a compensation payment complementing the fee for the Research License and a revenue sharing mechanism has to be in place prior to such application.
- 7. Any results from the use of the Research License cannot be used in research and development or service projects with external partners (other Research Institutions, commercial partners or external companies) unless agreed after consultation of Bio-Prodict and a written agreement. Such agreement will include a settlement of intellectual property rights and revenue sharing.
- 8. Bio-Prodict provides no rights to use the results of such research project in commercial applications of any kind including, without limitation, licensing and sales, acquisition of projects, manufacturing, quality control or commercial services such as reporting the results of Customer's activities for a fee or other form of consideration.
- 9. Bio-Prodict will only give limited support. Access to existing documentation and online instruction videos will be provided, but availability of introductory expert support will be limited. At the request of the Research Institution Bio-Prodict may provide additional support at additional costs.
